

Twenty Five (25) Year Limited Warranty Mill Finish Acrylume D.C.S.M. Metal Roof Panels

Manufacturer shall warrant the galvalume metal roof against rupture, perforation, structurally failing due to normal atmospheric conditions for a period of twenty five (25) years

This warranty is subject to the following conditions:

- 1. Finished product is installed as per manufacturer's specifications within thirty days of material being received.
- This Limited warranty shall apply only to roof systems installed in areas of normal atmospheric exposure and specifically does not cover failures or defects caused, in whole or in part, by any one of the following:
 - a. Areas subject to saltwater marine atmosphere or regular spray of either salt or fresh water.
 - Areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, or animal waste.
 - Areas subject to water runoff from lead or copper flashings or areas in metallic contact with lead or copper.
 - d. Conditions / circumstances where corrosive fumes or condensates are generated or released inside the building.
 - Failure to provide free drainage of water, including internal condensation, from overlaps on all other surfaces of the panels.
 - f. Failure to remove shavings and/or debris from the overlaps and all other surfaces of the panels.
 - g. Deterioration of the panels caused by contact with green or wet lumber or wet storage stain caused by water damage or condensation.
 - Presence of damp insulation or other corrosive materials in contact with or close proximity to panels.
- This warranty is strictly limited to the roof system and does not apply to failures, leaks, or damage caused by the installation of this product.
- 4. Light rippling or wrinkles, otherwise known as "oil canning," is primarily a cosmetic issue and has no affect on the warranty of the system. Oil canning is not a cause for rejection.
- 5. All claims must be submitted in writing to D.C.S.M., Inc. within the Warranty period and within thirty (30) days of the discovery of failure or defect in the roof system, and Owner must give D.C.S.M., Inc. reasonable opportunity to inspect the material. Failure of the Owner to do so shall relieve D.C.S.M., Inc. of any and all responsibility and/or liability under the terms hereof. Owner must provide with its claim, records to allow D.C.S.M., Inc. to establish the original order number, date of delivery of material, and date of installation. All notices given under this warranty shall be in writing and sent to D.C.S.M., Inc., 5700 Washington Street, Naples, FL 34109.
- 6. The liability of D.C.S.M., Inc. for warranty infringement is strictly limited to repairing or replacing the non-conforming panels and has no liability for labor costs associated with removing defective panels and/or replacing with new material. D.C.S.M., Inc. will have the sole discretion to determine if the failing panels will be repaired or replaced. Expenses shall not exceed the original cost of the material within the first year, and it will be pro-rated every year after.
- 7. This warranty is extended to the Owner as listed below and is nontransferable and nonassignable.
- 8. The effective date of this warranty shall be the date of manufacturing and/or the original material invoice date.
- No modifications or amendments of this Warranty shall be binding on D.C.S.M., Inc. or the installing contractor unless made in writing and signed by their authorized representatives.
- D.C.S.M., Inc. shall not have any obligation under this Warranty unless all invoices for materials have been paid in full.
