Thirty Five (35) Year Limited Paint Warranty
Pre-Painted Galvalume with Kynar 500 Paint Finish D.C.S.M. Metal Roof Panels

Subject to the provisions contained herein, manufacturer warrants that during the Thirty Five (35) Year Warranty Period, the paint will not chip, crack, peel, flake, or check. Subject to the provisions contained herein, manufacturer warrants that for twenty (20) years when installed vertically or not more than eighty-six (86") from the vertical, the Coating will not chalk in excess of ASTM D-4214-89 method D659 number eight (8) rating, or change color more than Five (5.0) Hunter ΔE units as determined by ASTM method D-2244-2. Color change will be measured on an exposed painted surface that has been cleaned of surface soils and chalk, and the corresponding values measured on the original or unexposed surface. It is understood that fading or color change may not be uniform, if the surfaces are not equally exposed to the sun and elements

This warranty is subject to the following conditions:

1. Finished product is installed as per manufacturer's specifications within thirty days of material being received.
2. This Limited warranty shall apply only to roof systems installed in areas of normal atmospheric exposure and specifically does not cover failures or defects caused, in whole or in part, by any one of the following:
 - a. No warranty is provided for the coating or substrate that is subjected to sea spray or installed on a property located 1,500 or fewer feet from a coastline, salt or brackish water, or any salt water environment.
 - b. Damage from wind, deliberate damage, improper handling by erectors, from abrasive or chemical cleaners.
 - c. Fire or other casualty or physical damage
 - d. Unusual harmful fumes, foreign substances in the atmosphere, or standing water.
 - e. Intermittent or continual submersion in water or any other liquid or solid material.
 - f. Damage from wind, deliberate damage, improper handling by erectors.
 - g. Any product stored or installed in a way that allows for poor air circulation, contact with animals, or animal waste.
 - h. Failure due to corrosion of substrate, improper installation on uneven or irregular substrates.
 - i. Failure to remove shavings and/or debris from the overlaps and all other surfaces of the panels.
 - j. Failures or defects that are caused as a result of acts of God, war, vandalism, radiation, falling objects, external forces, explosions, chemical sprays, falling sand or cement.
3. This warranty is strictly limited to the roof system and does not apply to failures, leaks, or damage caused by the installation of this product.
4. Light rippling or wrinkles, otherwise known as "oil canning," is primarily a cosmetic issue and has no affect on the warranty of the system. Oil canning is not a cause for rejection.
5. Due to pigment limitations, Regal Red and Matte Black are covered by a number eight (8) rating for chalk, and five (5) ΔE units for fade for a period of ten (10) years from installation. Metallic colors have no rating available for color change.
6. All claims must be submitted in writing to D.C.S.M., Inc. within the Warranty period and within thirty (30) days of the discovery of failure or defect in the roof system, and Owner must give D.C.S.M., Inc. reasonable opportunity to inspect the material. Failure of the Owner to do so shall relieve D.C.S.M., Inc. of any and all responsibility and/or liability under the terms hereof. Owner must provide with its claim, records to allow D.C.S.M., Inc. to establish the original order number, date of delivery of material, and date of installation. All notices given under this warranty shall be in writing and sent to D.C.S.M., Inc., 5700 Washington Street, Naples, FL 34109.
7. The liability of D.C.S.M., Inc. for warranty infringement is strictly limited to repairing or replacing the non-conforming panels and has no liability for labor costs associated with removing defective panels and/or

replacing with new material. D.C.S.M., Inc. will have the sole discretion to determine if the failing panels will be repaired or replaced. Expenses shall not exceed the original cost of the material within the first year, and it will be pro-rated every year after.

8. The effective date of this warranty shall be the date of manufacturing and/or the original material invoice date.
9. No modifications or amendments of this Warranty shall be binding on D.C.S.M., Inc. or the installing contractor unless made in writing and signed by their authorized representatives.
10. D.C.S.M., Inc. shall not have any obligation under this Warranty unless all invoices for materials have been paid in full.

THE LIABILITY OF D.C.S.M., INC. SHALL NOT EXTEND TO PERSONAL INJURY, PROPERTY DAMAGE, LOSS OF PROFIT, DELAY OR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM THE FAILURE OF ANY PANELS TO CONFORM WITH THE PROVISIONS IF THIS LIMITED WARRANTY.
