



**Forty (40) Year Limited Paint Warranty  
26 gauge Pre-Painted Galvalume D.C.S.M. Metal Roof Panels**

For forty (40) years the paint finish will not peel, flake, or otherwise lose adhesion to an extent that is apparent on ordinary outdoor visual observation. For thirty (30) years roof panels will not change more than seven (7)  $\Delta E$  (delta E) Hunter units when measured per ASTM D 2244 on clean surfaces after removing dirt, other surface deposits and chalk per ASTM D 3964. For thirty (30) years roof panels will not chalk more than a number six (6) rating when measured per ASTM D 4214, Method A

This warranty is subject to the following conditions:

1. Finished product is installed as per manufacturer's specifications within thirty days of material being received.
2. This Limited warranty shall apply only to roof systems installed in areas of normal atmospheric exposure and specifically does not cover failures or defects caused, in whole or in part, by any one of the following:
  - a. Areas that have suffered scratching or abrasion or has been damaged by abrasive or chemical cleaners.
  - b. Any roof panels installed within 1,000 meters or fewer from salt water environment.
  - c. Harmful fumes or foreign substances in the atmosphere, or salt spray.
  - d. Significant differences in insulation below coated metal panel.
  - e. Where materials/items such as snow guards and solar panels are attached/adhered to the product.
  - f. Has been abused, altered, modified, used in a manner not originally intended, or stored contrary to recommendations.
  - g. Has been stored or installed in a way which allows standing water on the coating or in any chemically aggressive environment (containing such substances as fumes, ash, salts, dirt, grease, or high humidity).
  - h. Has been stored or installed in such a way that allows contact with animals and/or animal waste or its decomposition products.
  - i. Failure to remove shavings and/or debris from the overlaps and all other surfaces of the panels.
3. This warranty is strictly limited to the roof system and does not apply to failures, leaks, or damage caused by the installation of this product.
4. Light rippling or wrinkles, otherwise known as "oil canning," is primarily a cosmetic issue and has no affect on the warranty of the system. Oil canning is not a cause for rejection
5. All claims must be submitted in writing to D.C.S.M., Inc. within the Warranty period and within thirty (30) days of the discovery of failure or defect in the roof system, and Owner must give D.C.S.M., Inc. reasonable opportunity to inspect the material. Failure of the Owner to do so shall relieve D.C.S.M., Inc. of any and all responsibility and/or liability under the terms hereof. Owner must provide with its claim, records to allow D.C.S.M., Inc. to establish the original order number, date of delivery of material, and date of installation. All notices given under this warranty shall be in writing and sent to D.C.S.M., Inc., 5700 Washington Street, Naples, FL 34109.
6. The liability of D.C.S.M., Inc. for warranty infringement is strictly limited to repairing or replacing the non-conforming panels and has no liability for labor costs associated with removing defective panels and/or replacing with new material. D.C.S.M., Inc. will have the sole discretion to determine if the failing panels will be repaired or replaced. Expenses shall not exceed the original cost of the material within the first year, and it will be pro-rated every year after.
7. The effective date of this warranty shall be the date of manufacturing and/or the original material invoice date.
8. No modifications or amendments of this Warranty shall be binding on Dan's Custom Sheet Metal, Inc. or the installing contractor unless made in writing and signed by their authorized representatives.

9. Dan's Custom Sheet Metal, Inc. shall not have any obligation under this Warranty unless all invoices for materials have been paid in full.

**THE LIABILITY OF DAN'S CUSTOM SHEET METAL, INC. SHALL NOT EXTEND TO PERSONAL INJURY, PROPERTY DAMAGE, LOSS OF PROFIT, DELAY OR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM THE FAILURE OF ANY PANELS TO CONFORM WITH THE PROVISIONS IF THIS LIMITED WARRANTY.**
